Lakes permitted to fish include: Griffin, Eustis, Harris, Little Harris, Denham, Dora, Beauclaire, Carlton, Trout, and Horseshoe. North boundary: Moss Bluff Lock and Dam on the Oklawaha River. Southern boundary: Apopka-Beauclaire Lock.
