

ATTENTION: Clear Bag Policy for Bon Secours Wellness Arena

Each guest will be permitted to carry one large clear bag, either a Ziploc style bag or a 12"x 6"x12" clear bag, plus a small clutch purse (4.5"x 6.5"). The small clutch must be carried into the venue outside the clear bag and is subject to search.

Clear bags provide another layer of security with less inconvenience to our guests as they are easier and faster to search. It also supports the Department of Homeland Security's "See Something, Say Something" campaign.

Approved bags include:

- Bags that are clear, vinyl or PVC and do not exceed 12"x 6"x12"
- One-gallon clear plastic freezer bags (*Ziploc bag or similar*)
- Small clutch bags, with or without a handle or strap, that do not exceed 4.5"x 6.5"

An exception will be made for medically necessary items after proper inspection upon entry.

Prohibited bags include, but are not limited to:

- Purses larger than a clutch bag
- Briefcases
- Backpacks
- Cinch bags
- Fanny packs that are not clear and exceed size restriction

Diapers and other baby supplies can be carried in a clear bag. Each member of a family, including children, is allowed to carry an approved clear bag and a clutch purse into the arena.

Complimentary clear bags will be available to guests attending events as we transition through this new policy.

Prohibited Items

We ask all guests to arrive early and travel light, as you may be subject to search, which includes metal detecting hand wands upon entry. For safety reasons, prohibited items include but are not limited to:

- External Flash Cameras
- Cameras with an interchangeable/detachable lens (*No professional photography*)
- Audio/Visual Recording Devices
- Tripods/Monopods
- Laser Pointers
- Laptop/Tablet computers,
- 2-way radios, flashlights
- Bags (*backpacks, large bags, suitcases, luggage*): Clear bags are permitted and may not be larger than 12"x 6"x12"
- Flammable liquids
- Chains or studded bracelets
- Illegal Drugs/Substances
- Fireworks
- Flashlights
- Balloons/Permanent Markers and Spray Paint
- Unapproved Pamphlets/Handouts/Ads
- Patrons without shoes or shirts
- Outside Food & Beverage
- Alcohol
- Oversized bags and backpacks (*may not be larger than 12" x 12"*)
- Beach Balls or Projectiles
- Skateboards, Segways, rollerblades, hoverboards, bicycles, helmets, chairs
- Cans and Bottles
- Pointed Tip umbrellas
- Pets (*other than service animals*)
- Glass, metal or plastic containers of any kind
- Cans/Bottles/Flasks
- Permanent markers, spray paint
- Masks
- Selfie Sticks
- Weapons, pepper spray, mace, flares or fireworks



CLEAR BAG POLICY

ITEMS APPROVED FOR ENTRY



CLEAR TOTE
No larger than 12" x 6" x 12"
One bag per person



PLASTIC STORAGE BAG
One gallon, re-sealable, clear
One bag per person



SMALL CLUTCH BAG
No larger than 4.5" x 6.5"
With or without strap
One bag per person
