OFFICIAL PRACTICE DAYS	July 29, 30, 31, 2019	During official practice, competitors may only fish with other competitors per Rule 3ii.
TOURNAMENT WATERS OFF-LIMITS	There are no off-limits.	
TOURNAMENT WATERS	The Mississippi River, pools 7, 8 & 9 and all rivers, creeks and canals connecting to the Mississippi River. The North Boundary is Lock & Dam #6 at Mile Marker 714: the South Boundary is Lock & Dam #9 at Mile Marker 648. Only that water open to ALL public fishing is to be considered tournament waters. Any water within these boundaries posted Off-Limits or No Fishing by State or Federal agencies will be Off-Limits to the tournament anglers. Wisconsin license is required.	
FISHING LICENSE	Online: http://dnr.wi.gov/topic/fishing/outreach/FishingLicenses.html There is a reciprocal agreement between Wisconsin, Minnesota and Iowa between the tracks. The RR tracks that run on both sides of the river. If you go past the tracks on either side, you must have that states license.
