2022 Bassmaster Open Tournament Guidelines

Enclosed in both Pro and Co-angler packets!!

- 1. You will need your own Coast Guard approved life vest and wear at all times the combustion engine is running (both practice and competition). **Read rule # 5(i) about inflatable PFD's**
- 2. You must wear an official B.A.S.S. patch/logo on front of shirt or a B.A.S.S. hat. Co-anglers will receive a B.A.S.S. hat at tournament registration. **Read rule #24**. Faliure to meet logo requirements may result in not being able to weigh your catch and/or a \$100 fine. The logo can be downloaded at https://www.bassmaster.com/bass-member-logo-embroidery-file.
- 3. You may be required to show the appropriate state(s) fishing license at the official registration. Coanglers should have ALL licenses to cover any waters that may be fished during the competition.
- 4. **Co-anglers** -Please try to limit your tackle to one large or two small tackle boxes and no more that six rods and reels. Safe and secure storage can be limited.
- 5. Keep fresh **WATER** in your weigh-in bag at all times. Monitor fish throughout the tournament day.
- 6. If for any reason you must cancel from the tournament, you are required to notify someone on the B.A.S.S. staff as soon as possible.
- 7. It is **VERY IMPORTANT** that you contact your next day's partner as soon as possible after you weigh-in each day. Your next day partner name and contact info will be sent to you via text message and printed on your weigh in receipt. Text cannot be received if cell carrier has short code blocking in place. Blocking can be removed by calling your carrier. Also, a pairing board will be posted at registration and at the weigh-in site if you do not weigh in or if you do not have text messaging.
- 8. Do not pass any information about your partners' fishing locations to your next day's partner.
- 9. Co-anglers must fish from the back of the boat; you may leave the back to land a fish. There **IS NOT** a line drawn down the middle of the boat, but please respect your Pro. For example, DO NOT cast over his line. **Read rule # 6.**
- 10. During the course of the tournament day, Co-anglers can only operate the boat in the case of an emergency or an exception from tournament director. See rule #13
- 11. **Pros cannot** tell co-angler not to fish. **Co-anglers** cannot accept money from the Pro not to fish.
- 12. NO alcohol or non-prescribed drugs are allowed in the boat.
- 13. We suggest you meet your partner prior to arriving at the boat ramp or marina in the mornings due to limited parking space.
- 14. IMPORTANT: Read rule #3 "Pre-Tournament Practice" very carefully. DURING OFFICIAL PRACTICE YOU CANNOT FISH WITH OR RECEIVE INFORMATION FROM ANYONE WHO'S NOT A COMPETITOR IN THE TOURNAMENT.
- 15. **Co-anglers** are allowed to practice out of their boat. Your boat must adhere to all rules and you must have proof of insurance with you.
- 16. Only non-penertrating culling clips and culling beams are allowed for use.

- 18. Pro anglers and co-anglers should respect each other and each other's equipmement throughout the tournament day.
