TOURNAMENT CHECK-IN / BRIEFING DATE	March 1, 2023	REGISTRATION REMINDER: All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. You will be fined for being late.

OFFICIAL REGISTRATION / ON SITE CHECK-IN	2:00 pm to 4:20 pm via Time slots. Time slots will be emailed tournament week.	
TOURNAMENT BRIEFING	Virtual - All Contestants must view.	
OFFICIAL PRACTICE DAYS	February 25 – March 1. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS @ 1:00 PM LOCAL TIME ON CHECK-IN DAY. During official practice, competitors may only fish with other competitors per Rule 3ii.	
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Monday January 30 and extend through Saturday, February 25 @ safelight. During this time you are not allowed on tournament waters.	
TOURNAMENT WATERS	Tournament waters will be Lake Eufaula and any creeks and canals connected to Lake Eufaula. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. No Locking	
FISHING LICENSE	Alabama is required. Online: https://www.outdooralabama.com/licenses/freshwater-fishing-licenses ** Georgia License is also accepted	
FISH LIMITS	Pro-Angler: 5 fish / Co-Angler: 3 fish / 14" minimum length

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.

Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
