TOURNAMENT WATERS

Lake Hartwell and all rivers, canals, and creeks connecting to Lake Hartwell. Only water open to ALL public fishing will be considered tournament waters. Only water accessible from the main body of Lake Hartwell will be considered accessible. Must launch from a designated launch per the google maps compiled list provided.

FISH LIMITS

Pro-Angler: 5 fish 12" minimum length

SCORING

The five longest verified lengths each day will be totaled for the angler's score. Only the Black Bass Species consisting of the following: Largemouth, Spotted, Guadalupe, Shoal, and Smallmouth bass and any hybrid of the above are accepted species. **Only Ketch boards will be the official board** and Measuring devices must be brought to and approved at the registration and angler meeting.

Balance deadline dates are the dates the balances are due. You will not receive any further notices on the balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.

Deposits are non-refundable and non-transferable regardless of the date of cancellation. Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on the waiting list should not pay the balance until contacted by the tournament department.
