**REGISTRATION REMINDER:** All anglers must register in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. **You will be fined for being late.**

**OFFICIAL PRACTICE DAYS**

June 4 – June 6, 2023  
During official practice, competitors may only fish with other competitors per Rule 3ii.

**PRE -TOURNAMENT OFF-LIMITS**

There are no tournament waters off-limits. But most rules start with official practice.

**TOURNAMENT WATERS**

The Potomac River and all rivers, creeks and canals connecting to the Potomac River. No boats allowed past a straight line from Smith Point to Point Lookout at the entrance to Chesapeake Bay. Only that water open to ALL public fishing will be considered tournament waters. Any water within these boundaries posted Off-Limits or No Fishing by State or Federal agencies will be Off-Limits to the tournament anglers

**FISHING LICENSE**

Maryland Tidal license is required. Online: <https://compass.dnr.maryland.gov/>

**Above the Woodrow Wilson Bridge:** You are required to have a District of Columbia Fishing License.

**FISH LIMITS**

Pro-Angler: 5 fish / Co-Angler: 3 fish / 12" minimum length

**ENTRY FEES**

PRO ENTRY FEE \$200	BALANCE: \$200	BALANCE/ENTRY DUE DATE: <b>May. 9, 2023</b>
CO-ANGLER ENTRY FEE \$100	BALANCE: \$100	BALANCE/ENTRY DUE DATE: <b>May. 9 , 2023</b>

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.

**Deposits are non-refundable and non-transferable regardless of date of cancellation.** Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
