TOURNAMENT CHECK-IN / BRIEFING DATE	Sept 13, 2023 REGISTRATION REMINDER: All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. You will be fined for being late.

OFFICIAL REGISTRATION / ON SITE CHECK-IN	2:00 pm to 4:20 pm via Time slots. Time slots will be emailed tournament week.		
TOURNAMENT BRIEFING	Virtual - All Contestants must view.		
OFFICIAL PRACTICE DAYS	Sept 9 – Sept 13. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS @ 1:00 PM LOCAL TIME ON CHECK-IN DAY.  During official practice, competitors may only fish with other competitors per Rule 3ii.		
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Monday August 14 and extend through Saturday, Sept 9 @ safelight. During this time you are not allowed on tournament waters.		
TOURNAMENT WATERS	Tournament waters will be Watts Bar and any creeks and canals connected to Watts Bar. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. NO LOCKING

FISH LIMITS	Pro-Angler: 5 fish / Co-Angler: 3 fish / 15" minimum length Largemouth/spotted 18" smallmouth
