TOURNAMENT WATERS

Anglers can launch at any public access on pools 7,8, and 9 of the Mississippi River & its connected 'backwaters' that are on the official **LAUNCH LIST**. The eastern launch boundaries will be ramps/ public access along or to the west of Great River Rd/Hwy 35. The western launch boundaries will be ramps/access along or east of Great River Rd (X52) & Hwy 26, Hwy 16, & Hwy 14/61. Anglers must launch within the boundaries but can pedal or paddle up as far as they can. No portaging is allowed. A body of water must be connected, navigable to the Mississippi to be considered legal.

FISHING LICENSE

FISH LIMITS

Pro-Angler: 5 fish 12" minimum length

SCORING

The five longest verified lengths each day will be totaled for the angler's score. Only the Black Bass Species consisting of the following: Largemouth, Spotted, Guadalupe, Shoal, and Smallmouth bass and any hybrid of the above are accepted species. **Only Ketch boards will be the official board** and Measuring devices must be brought to and approved at the registration and angler meeting.

Balance deadline dates are the dates the balances are due. You will not receive any further notices on the balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.

Deposits are non-refundable and non-transferable regardless of the date of cancellation. Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on the waiting list should not pay the balance until contacted by the tournament department.
