Lake Winnebago and any creeks and canals connecting to Lake Winnebago. Only that water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be close to this tournament's contestants.

**FISH LIMITS**

Pro-Angler: 5 fish / Co-Angler: 3 fish / 14" minimum length

Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
