OFFICIAL PRACTICE DAYS	January 27–31. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS @ 12:00 PM LOCAL TIME ON CHECK-IN DAY. During official practice, competitors may only fish with other competitors per Rule 3ii.		
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Saturday, January 13, and extend through Saturday, January 27 @ safelight. During this time you are not allowed on tournament waters. During the Off-Lim period, practice, and competition, anglers cannot solicit, gather or intentionally receive ar information from anyone other than another competitor in the tournament.		
TOURNAMENT WATERS	Lake Okeechobee and all rivers, creeks and canals connecting to Lake Okeechobee. You are only allowed to lock into J & S Canal, Taylor Creek, Buckhead, Henry and Lakeport. Only that water oper to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. No Locking into the Kissimmee River Lock, Port Mayaca Lock (St. Lucie River) and the Moore Haven Lock (Caloosahatchee Canal).
