OFFICIAL PRACTICE DAYS	March 2- 6. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS @ 12:00 PM LOCAL TIME ON CHECK-IN DAY. During official practice, competitors may only fish with other competitors per Rule 3ii.		
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Saturday, February 17, and extend through Saturday, March 2 @ safelight. During this time you are not allowed on tournament waters. During the Off-Limits period, practice, and competition, anglers cannot solicit, gather or intentionally receive any information from anyone other than another competitor in the tournament.		
TOURNAMENT WATERS	Tournament waters will be Santee Cooper lakes and any creeks and canals connected to Santee Cooper. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. No Locking
