<i>Pre-Tournament Off-Limits</i>	Off-limits will begin on Saturday, February 19 <sup>th</sup> and extend until March 14 <sup>th</sup> at safe light.
<i>Official Practice Days</i>	March 15 <sup>th</sup> to March 19 <sup>th</sup> All competitors must be off tournament waters at 4:00 P.M local time on Friday, March 19 <sup>th</sup> .
<i>Official Tournament Board Check/Registration</i>	February 23 <sup>rd</sup> from 4:00 pm to 6:00 pm. <u>Check-In Reminder:</u> All anglers must check-in in person with B.A.S.S. staff on-site. This will be the only check-in period. <b>MANDATORY FOR ALL</b>
<i>Check-in Location</i>	Tenkiller Lodge, 26247 State Hwy 82, Park Hill, OK 74451
<i>Tournament Briefing</i>	In Person or Virtual – All contestants must view.
<i>Tournament Waters</i>	Anglers are allowed to fish any legal and connected body of water or portion of Lake Tenkiller as long as they launch and land from the published launches and follow all BMKS rules. No portaging or wading. Anglers must use launches from the following list for competition days. This list is subject to updates. Participants are expected to contribute to this list both in additions or removal of launches as needed by communicating with the TD. No additions will be made after 3/18/24.
