#### What comes with my booth?



- Each 10' x 10' booth will be set with 8' high blue & white back drape and 3' high blue side drape. Booths 300 SF (square feet) or less will receive an identification sign. Booths larger than 300 SF may receive an identification sign upon request.
  - Please note that booths in the exhibit hall are not carpeted and require carpet.
  - Booths in the Ballroom and Concourses do not require carpet.

#### I'm a small 10x10 booth and I want to carry my stuff in. What can I do?

Since the Fort Worth Convention Center is located in a downtown area, street parking is very limited, and it is recommended to park in the Houston Street Garage or the Commerce Street Garage which are across the street. Parking charges may apply.

# I have a trailer full of my booth supplies, can I just drive up to the dock and unload?

 With a show the size of ours, moving and unloading in the dock is handled through a queue system at a Marshalling Yard. Freeman will unload your supplies via forklift for a cost. If you would like to avoid any cost, then you can unload by hand and carry your supplies from the local parking garages.

#### What time can I enter the building on set up days and show days?

- For set up days, we do ask that you enter in coordination with your Targeted Move-in time to allow the set up crew to not be interrupted.
- For show days, you can enter as early as 8am and you must present your credential.
   We ask that all exhibitors limit guests to only working staff members with credentials. Please pay attention to show communication for more information regarding exhibitor entrance locations.

## I am selling products at the show. Do I have to fill out any forms or tax information?

The tax rate in Fort Worth, TX, is 8.25%. The State of Texas will be given a list of the
registered exhibitors, and they may reach out to you individually to ensure
compliance. The State may have representatives on site to hand out payment
procedures.

## I am sampling products at the show. Do I have to fill out a form or let the facility know?

- Sampling at the Fort Worth Convention Center is a little different than other cities because you will have to apply for a Temporary Permit through the Health Department.

## More information regarding Sampling

- If a vendor is sampling any food products at the event they will be required to have a temporary permit. Please note that liquids count as food. And if you are sampling drinks, you will need to apply for a Temporary permit.
- If a vendor is cooking and/or sampling any TCS products they will need a stem thermometer, test strips for bleach, a dish washing station, and a hand washing station along with utensils and a food covering.
- If a vendor is a cottage food vendor and want to sample on site, they will need a
  Health permit
- If a cottage food vendor is sampling pre-packaged food items and not handling anything they will <u>not need a permit</u>
